The programme is implemented by Gargaara Company Limited, with funding administered by KfW Entwicklungsbank (KfW) under BMZ Reference No. 2020 67 239. Gargaara Company Limited serves as the executing agency, while DT Global (EA) Company Limited acts as the implementing consultant.
- 3. Gargaara Company Limited intends to apply the proceeds of this grant to cover eligible payments under the contract referenced in this Tender Notice. The services will be procured in three separate lots:
 - Lot 1: Banadir Region





- Lot 2: Greater Southern Somalia Region
- Lot 3: Somaliland Region

Applicants may submit proposals for one, two, or all three lots. However, each lot will be awarded to a different individual consultant.

- 4. Gargaara Company Limited now invites applications from qualified individual consultants to submit quotations for the above-mentioned services.  - b. **Design** of tailored BDS mentorship programs for Women and Youth- led MSMEs
 - c. **Implementation** of the Women and youth-led MSME BDS mentorship programs
 - d. Monitoring, Evaluation (M&E), and follow-up activities
